BUK's Education Arts Program Get NUC's Full Accreditation

Il Education Arts Program in Bayero have been given full accreditation status by the National Universities Commission (NUC) in the accreditation exercise it conducted recently.

The programs, Education Arabic, Education English, Education History, Education Hausa and Education Islamic Studies, were visited by the NUC accreditation team in October last year led by a Professor.

A letter containing the result of the October 2012 accreditation result, written to the Vice Chancellor and signed by the Deputy Executive Secretary of the Commission, A. S. Agbaoye, indicated that the NUC was satisfied with all the programs and granted them full status.

Prof. Yadudu Faults Constitution Review, Says Process ill-Defined

Professor Auwalu Hamisu Yadudu has berated the ongoing constitution review in the country and described its altering process as ill-defined, not transparent and open to manipulation.

Prof. Yadudu made this known at a public lecture he delivered at the Musa Abdullahi Auditorium, BUK, organized by the University's Public Lecture Series Committee on Wednesday 13th March, 2013, titled, "2013 Proposed Constitution Review Issues at Stake".

The lecturer opined that to a neutral observer and commentator the whole process of constitution review might encounter a slow or a sudden death because the mechanics of the alteration process is practically deficient, citing an example of former President Obasanjo's purported third term agenda, which suffered sudden death before the second reading at the Senate.

Professor Yadudu, who is a Lecturer in the Department of Private and Commercial Law and a former Legal Adviser to two former Heads of State from 1994 – 1999, also disagreed with the dual track approach currently adopted by the two chambers of the National Assembly, saying the altering process is dilatory, leading to resource waste and bickering.

The legal luminary averred that in the event of too many issues on the agenda to contend with by the two legislative bodies, the process would be unmanageable and mutually destructive. He particularly commended the procedure of the Justice Uwais-led Electoral Reform Committee, which focused only on how to reform Nigeria's electoral system.

The former Legal Adviser explained that both chambers of the National Assembly have framed differently the issues to be addressed in the current amendment process.

"The Senate lays out the issues in an open-ended way while the House of Representatives frames their own in a



referendum fashion or specific ways", he added.

He noted that at public hearings the people unrestrained by the agenda set have framed their own key issues: economy, security and welfare.

Prof. Yadudu identified the key roles played by the invisible hands of the executives and political parties in the constitution review, but noted that in the normal course of events, they should not play more than what role the constitution has assigned to them.

The Speaker advised that there was the need "to adopt, by way of a new legislation, a road map for constitution amendment that is truly participatory, engender, consensus building and sorts out some identified gray areas".

The Legal Practitioner advocated the need to amend the constitution in an incremental step devoted to a few manageable issues such as deepening the electoral reform.

He tasked the National Assembly to adopt a legislative agenda from inception to address a few issues over the course of its tenure rather than many issues that cannot be addressed.

In his speech, the Chairman of the occasion, Alhaji Abubakar Mahmoud, SAN, CON said the lecture came at a time when the country had been

making effort to review its constitution.

He said given Prof. Yadudu's over two decades in the scheme of constitution reforms in the country, his wealth of experience would add value to the public lecture.

Prof. Mahmoud, who is the Pro-Chancellor of the Kano University of Science and Technology (KUST), said the event was meant to allow for cross fertilization of ideas, as the University tradition.

On his part, the Vice Chancellor Professor Abubakar Adamu Rasheed, mni, MFR, who was represented by the Deputy Vice Chancellor. Academics, Professor Muhammad Yahuza Bello, said the University attached great importance to **Public** Lecture. He said the management revived the Public Committee Lecture Series and charged it to organize lecturers monthly.

Prof. Rasheed emphasized that the University's Committee of Deans and Directors (CDD) sponsors up to 50 academic staff for conferences to present papers abroad. He said there was a new guideline from July this year that such staff must present their papers at the Faculty and departmental levels, in order to add value and open a room for criticism internally.
