BUK Corrects Daily Trust Story

B ayero University has issued a rebuttal to a news report published by the *Daily Trust* newspaper edition of Monday, 13th July, 2015 in which it reported that all was set for the election of a new Vice-Chancellor impliedly on Tuesday, 14th July, 2015.

The erroneous report said the new Vice Chancellor would be elected during the University's Congregation meeting.

The rebuttal issued by the Director Public Affairs, Ahmad Shehu offered the following clarifications:

- 1. "Bayero University, Kano wishes to make it categorically clear that it **never** scheduled any Congregation meeting for Tuesday, 14th July, 2015.
- 2. "Congregation meetings are not an avenue for the appointment/selection of Vice Chancellor for Bayero University, Kano.
- 3. "Congregation meetings are gathering of all graduate employees of the University, where they meet from time to time and interact with a view to discussing extensively issues affecting the University generally and proffer advice where necessary as stakeholders in the affairs of the institution.
- 4. "It is true that Bayero University has a local arrangement PECULIAR TO IT ONLY where aspirants shortlisted for the post of Vice Chancellor pass through Community acceptability test at Congregation meeting.
- 5. "And, the result of the interaction with the candidates at the Congregation would be passed to the Selection Board for its consideration.
- 6. "The only Congregation scheduled by the University is going to hold on Tuesday, 21st July, 2015 and not 14th July, 2015 as erroneously reported by the newspaper.

- 7. "We wish to advise members of the media to always crosscheck their facts before rushing to press to avoid a situation like this.
- 8. "Bayero University operates an open-door policy and will always welcome members of the fourth estate of the realm for any information about the University."
