

SyWAL Harps on More Researches in West African Languages

Isa Muhammad Inuwa from Vienna, Austria

The second Symposium on West African Languages, tagged SyWAL 2016, ended in Vienna, Austria, calling for concerted efforts of Universities and research institutes around the globe to intensify their researches on the widely spread languages of Africa, as there is more to be discovered about the languages of that phylum. the "Mouse" in terms of the amount of researches made on the languages.

The symposium drew linguists of repute from all the traditional linguistic schools around the world, such as the London school, represented by personalities such as Emeritus Professor Philip Jaggar, from the School of

Addressing the participants at the opening ceremony of the symposium, the head of the symposium organization, Professor Norbert Cyffer, observed that there was dire need for further look into African Languages with a view to developing some vital aspects the languages, particularly the phonology of most of these languages, which, he said had, received less attention. He added that since the initial efforts made in the typology of African languages by Joseph Greenberg and some other scholars, much was yet to be done in terms of developing researches in the languages.

In his remarks, the Assistant

head of the symposium organization, Dr. Georg Ziegelmeyer, announced that the symposium was the second of its kind, organized by the Department of African Studies of the University of Vienna, Austria that saying the last one was held in the year 2014. He noted that the idea behind organizing the symposium was to bring together scholars and experts in West African Languages with a view to finding out the current linguistic status of the languages.

While presenting his lead paper, Professor Firmin Ahoua, the Technical Adviser to the Minister of Water and Forests of the Republic of Cote D'Ivoire, compared the African languages to the proverbial "Elephant" and African and Oriental Studies, London. The American School was aptly represented by Emeritus Professor John Hutchinson from the Center for African Studies, University of Boston. The Prague school of linguistics was represented by Petr Zima from the Faculty of Humanities, Charles University, Prague.

Other prominent participants included Professor Nina Pawlak from Poland and others from Moscow in Russia, Hamburg and Bayreuth, Germany. Some African participants came from Ghana, Cameroun and Senegal. Nigeria was represented by Malam Tahir Abba and Malam Isa Muhammad Inuwa, both of the Department of Linguistics and Foreign Languages, Bayero University, Kano.

The Gender and Equal Opportunities Bill 2016 is basically "An Act to incorporate and enforce certain provisions of the United Nations Convention on the Elimination of all Forms of Discrimination Against Women, The Protocol to the African Charter on Human and People's Rights on the Rights of Women in Africa, and other matters connected herewith".

The Gender and Equal Opportunities Bill before the Senate Chambers comprises of 3 parts and 25 sections. It has passed the 2^{nd} Reading and is now at the Committee level to prepare for public hearing.

According to the Director of the Centre, Prof. Aisha Abdul Isma'il the essence of the Round Table is to deliberate and critically review the Gender and Equal Opportunities Bill and come up with an informed position relative to Islamic Personal Law and other related religious laws.

The meeting resolved to prepare a memo for submission to the Senate Committee at its public hearing.


