At 22nd Professorial Inaugural Lecture:

Prof. Falola Blames Prevalence of Poverty on Policy Flux

n erudite Scholar and Professor of Development Geography, Professor Julius Afolabi Falola, has identified inconsistency in programmes/policies and lack of continuation of laudable ones among them as the bane of the nation's development efforts. He said the most unfortunate aspect was that no matter how laudable such initiatives/policies had been, they are not allowed to run their full course. This, he argued, accounted for the prevalence of poverty in the land.

Professor Falola, who delivered the 22nd Professorial Inaugural lecture on the topic: The Poor We Have with us **Always,** on Thursday 26th October, 2017 at the Mahmud Tukur Theatre, Old Campus, stated that it was unfortunate that the nation had developed a notorious habit of abandoning programmes/policies no matter how good they are, and was always beginning all over again with the advent of a new administration, when according to him, development itself is a process and not a destination.

He observed with nostalgia that because no programme/policy no matter how good was ever allowed to run its full course via full implementation, 'the nation always takes one step forward and two steps backwards, 'he fumed.

Poverty according to the scholar was one of the greatest challenges facing humanity as a whole, saying that it was not a recent development, because there was no nation, tribe, race or colour that did not have terms to describe the phenomenon of poverty and the poor.

He said poverty exerts deleterious effect on the people's life and living, adding that even in places where there was no officially-declared caste system, you hardly find the rich marrying from poor families as if poverty is infectious.

The scholar who gave the statistics of poverty in Nigeria stated that there are several factors that are responsible for the poverty status in the country. He listed rising unemployment and under employment as some of the causes of poverty, saying that between 2010 and 2013, the unemployment rate had doubled. While the rate according to him dropped in 2014, it began to climb in 2015 to reach about three times the 2010 figure by the fourth quarter of 2016.

On under employment, Professor Falola stated that it rose from 16 percent in 2010 to 21 percent in 2016, adding that the greater proportion of the unemployed and underemployed are the youth as could be seen in the statistics released in the first quarter of 2016 by the National Bureau of Statistics. He said even among the employed in Nigeria only a few could afford good living – bearing in mind that the minimum wage is 18,000 Naira which some states are not even paying salary of their workers.

Professor Falola further stated that poverty was more excruciating in the rural areas, because agriculture, which was the major employer of rural labour and supplier of food, raw material for industry and export had suffered much neglect with consequent decline in the sector. Yet, Nigeria, he said, is replete with agricultural policies, programmes and projects targeted at reviving the sector, but which were not allowed to leave a lasting impact.

As a first step in tackling the root of poverty in the rural areas, Prof. Falola said was the restructuring of agricultural production through re-organization of production units. The first, he said, is the organization of peasant farmers into Family Farm Units (FFU), and the other is the promotion of cooperatives among new set of young farmers.

In conclusion, Professor Falola is of the opinion that, the multidimensionality of poverty called for efforts to attack poverty in a multidimensional way – education, health and standard of living. Doing this, would involve several stakeholders working as team to achieve the desired objectives.

"The challenge for Nigeria is not just one of bridging the gap between different parts of the country, but for the entire country to make a leap forward through drastic reorientation of policy to create the right atmosphere for advancement," he said.

Earlier, in his address, the Vice Chancellor, Professor Muhammad Yahuza Bello, represented by the Deputy Vice Chancellor, Academics, Professor Sagir Abbas, said that the importance of inaugural lecture was for the speaker to present and share with members of the academic community his areas of research as well as impart knowledge to members of the public. He said it was equally an avenue for the university to showcase its academic breakthrough and successes.

All Languages of the World Originated from Hausa By: Abubakar Yusuf Language - Prof. Souley Garba

A Nigeriene Egyptologist, Professor Souley Garba, has same meanings with each other, example of which was said that from the research he condcuted he found out that all languages of the world originated from Hausa language.

Professor Souley Garba disclosed this during a conference organized by Bayero University Centre for Research in Nigerian Languages and Folklore on 26th October, 2017 with the theme Finding on "Dan Baki Pyramid" in Zinder, Niger Republic.

He said the research showed that among the diverse languages in this world, Hausa language was the first to exist and all others emanated from it.

Professor Garba said when he compared Hausa language with Indian language, he found that many words have the

"Dogo" in Hausa, which means something tall. It is the same in Indian language. Also, "Gari" in Hausa means town, which also has the same meaning in Indian language.

He further stated that even the word maternity in English has a direct relationship with the word "mata" in Hausa language. In Hausa, according to him, the word "sun" is called "rana" while in French it is "ra," which shows that the two words have originated from a single source.

"My findings also showed that Hausa was the ancient language in Egypt from its point of origin," Professor Garba added.

Garba said he made the announcement on 29th February, 2012. He said it is located 20 km west of the city of Zinder and 2 km north of the village of Tirmini in Niger Republic.

He claimed that the "Dan Baki" pyramid was older than any of the Egyptian pyramids.

Executive Order No: 002 of 2017

By the Acting President of the Federal Republic of Nigeria

On submission of Annual Budgetary Estimates by all Statutory and Non-Statutory Agencies, including Incorporated Companies wholly owned by the Federal Government of Nigeria

HEREAS, there is an urgent need to ensure orderly planning and execution of government programmes and projects, while promoting the highest standard of accountability in all Federal Government Corporations, Agencies and Companies (hereinafter referred to as Agencies);

WHEREAS, the timely preparation and submission of budget estimates by Agencies will enhance performance, prudence and transparency as well as portray an accurate fiscal picture of the scope and extent of Government activities;

WHEREAS, the Federal Government of Nigeria is desirous of promoting coherence and proper coordination of the submission of budget estimates in its Ministries, Departments and Agencies as well as wholly-owned companies, and to standardize the financial operations of all Government Agencies and Companies;

WHEREAS, section 21 of the Fiscal Responsibility Act 2007 requires Government Agencies to, before the end of the second quarter of every year, submit to the Minister of Finance the schedules of estimates of revenues and expenditure of the Agencies for the next three financial years and to, before the end of August in each financial year, submit to the Minister of Finance their annual budgets derived from the estimates;

Now therefore, pursuant to the Authority vested in me by The Constitution as Acting President of the Federal Republic of Nigeria, I hereby order as follows:

- 1. All Agencies, whether or not listed in the Fiscal Responsibility Act, shall, on or before the end May every year, cause to be prepared and submitted to the Minister of Finance and the Minister of Budget and 7. National Planning their schedule of revenue and expenditure estimates for the next three financial
- 2. All Agencies shall, on or before the end of July every 8.

- year, cause to be prepared and submitted to the Minister of Finance and the Minister of Budget and National Planning their annual budget estimates, which shall be derived from the estimates of revenue and expenditure as projected in their three-year schedule.
- A joint committee of the Ministries of Finance and Budget and National Planning shall review such estimates and ensure their conformity with the national plan and the financial and budgetary regulations before processing them for approval and early transmission to the National Assembly.
- Supervising Ministers and Heads of Agencies as well as the Chief Executive Officers of Government owned companies shall verify that the process of preparation, harmonization and collation of budget estimates are as stipulated in relevant laws and guidelines as well as ensure strict compliance with this Executive order.
- Except with the express consent of the President, no payment shall be made in respect of any capital or recurrent liability of an Agency, other than payment of due salaries and allowances, unless the Agency has an approved budget and the payment is in conformity with the approval.
- Heads of Agencies and Chief Executive Officers of Government owned companies shall take personal responsibility and be subject to appropriate sanctions for any failure to comply with this order.
- Any revenue or other funds of an Agency in excess of the amounts budgeted and duly expended shall accrue to the consolidated revenue fund of the Federal Government.
- This Executive Order shall take effect immediately.

Call for Applications for the Australia Awards-Africa Scholarships

The National Universities Commission has received a call notification from the Australian High Commission, for applications from eligible candidates for the 2018 Short course and 2019 Postgraduate Australia Awards-Africa Scholarships. In a statement signed by the Director, International Cooperation and Liaison Services on behalf of the Executive Secretary, Mrs Constance N. Goddy-Nnadi, said the Scholarship scheme is part of Australia's development assistance to Africa in building critical skills and knowledge, through strategic foreign policy, economic diplomacy and development objectives across key sectors.

The Short-term award which commences in 2018, is a 1-3 months professional development training programme in specialized fields for African Professionals. Eligible candidates for the short term scholarship are Middle-Senior level professionals with Bachelor's degree or equivalent and currently employed in a relevant field. The training is delivered in Australia and various locations in Africa.

The postgraduate scholarship award, on the other hand commences in 2019, is for Masters degree level and open to applicants from Public and Private sectors as well as Civil Society Organizations. The objective of the award is to provide high quality training for talented Africans at an Australian University, who on completion, would significantly contribute to their respective national or regional development. According to

the statement, key sectors of focus for both the short course and postgraduate awards are; Agricultural productivity, Extractives and Public Policy. The two (2) year Masters degree scholarship covers the following:

- 1. Tuition fees and training materials;
- 2. Accommodation;
- 3. Contribution to Living expenses;
- 4. Health insurance for basic medical care in Australia and
- 5. Travel expenses to and from Australia

According to a statement signed by Supervisor of FUIW Secretariat, Dr. Ahmed Said ould bah, the prize comprises two categories.
