Physical Disability is no Barrier to Physical Activities ... Prof. Rabi'u Muhammad

Physical activities can help in directing the harmonious development of the body for mentally and physically defective persons to develop adequately, a Professor of Adapted Physical Education, Rabiu Muhammad, has said.

Presenting the 44th Professorial Inaugural Lecture, titled "Exercise and Sports for the Atypical Persons: A Multidimensional Analysis on Thursday, 8th August, 2019 at Musa Abdullahi Auditorium, he pointed out that a disabled person required an adapted physical education programme.

Professor Muhammad, a Professor in the Department of Physical and Health Education of Bayero University, Kano, said atypical persons were those with disabilities, such as visual and learning impairment, mental retardation, motor orthopedic, learning disabilities and communication disorder and, as such, their performance deviated from the normal trend, as a result of which they required the adapted physical education programme.

He described adapted physical education as the art and science of developing, implementing and monitoring a carefully designed instructional programme for a learner with disability based on a comprehensive assessment to give him or her the necessary skills for a life time rich in leisure, recreation and sport experience

to enhance physical fitness and wellness. He, therefore, called on physical educators who had done excellently well in helping healthy and gifted persons to become healthier and more skilled to do more in helping those with disabilities to develop their optimum physical capacities, which should help in improving their physical and mental wellbeing.

Professor Muhammad reiterated the fact that there was a barrier in the participation of persons with disability in physical activities and sports performance because of discrimination. As such, they were underrepresented. Adding that, in spite of the discrimination Nigerian athletes with disabilities faced, they had brought glory to Nigeria at Paralympic Games, winning more medals than their able-bodied counterparts.

Earlier the Vice Chancellor, Professor Muhammad Yahuza Bello, in his remarks, said the number of Professors that had presented their inaugural lectures was small compared to the number of Professors in the University and that the University management did not mind taking two lectures per day on the lecture day so as to get more Professors on board. He also commended the Inaugural Lecture Committee for doing tremendously well in the discharge of their duties, but urged them to sustain the tempo.

47 Staff on Fellowship Share N17 Million Research Grant

Over 17 million naira was approved by the Vice Chancellor, Professor Muhammad Yahuza Bello, for disbursement as research grants to 47 staff on fellowship who are pursuing higher degrees in various universities.

A statement signed by the Director, Directorate of Research, Innovation and Partnership (DRIP), Professor Ibrahim Ahmad Rufa'i, said the Standing Committee on Research and Publication of the Directorate had screened the 47 proposals for content and compliance with the University's guidelines on research grants and found the proposals apt.

According to the statement, 30 of the beneficiaries were pursuing PhD programmes and the remaining 17 staff on fellowship were undergoing Master Degree programmes. Both staff are expected to complete their programmes of study in 2020/2021.

It said that following full satisfaction of the fulfilment of the guidelines for the grants by the candidates, the Directorate had recommended the applicants to be awarded the research grants and were happy that the Vice Chancellor had graciously approved it.

Meanwhile, the Vice Chancellor, Professor Bello, had approved the disbursement of the sum of 30,000 naira each as theses grants to three PhD students. The approval was sequel to the recommendation of the Board of Research, Innovation and Partnership (DRIP), according to Professor Rufa'i.

Scholars in tertiary institutions must vigorously engage in innovation and critical thinking for out of the box solutions with a view to bailing out our country from the quagmire of under-development occasioned by the myriad of problems facing the society, the Chief Imam of BUK New Campus Mosque, Professor Sheikh Auwal Abubakar, has said.

Delivering his sermon on Sunday, 11th August, 2019



during the Eid-el-Kabir prayer, the cleric, however, said this could only be attained through the acquisition of knowledge by members of the society. He said any nation that relegated education to the background would forever remain backward and underdeveloped.

"Universities and other tertiary institutions must be up and doing. We must reawaken from our slumber and be more innovative in our thinking faculty. Our scholars should focus on indepth research in science and technology and other aspects of how best to be selfreliant, productive and development oriented for the overall interest of our nation," he declared. Professor Abubakar said it was disheartening that our scholars in universities could not afford to engage in meaningful research that would advance the development agenda so that the country could prosper and grow.

In particular, he said the North would continue to lag behind as long as "we shall not have peace, unity, and communal services. At the moment, we are in a disarray, everyone is concerned only about himself and members of his immediate family alone, and this is a negative trend which would be disastrous to our collective interest as a people and a nation."

He also harped on the need for unity, brotherhood, community service and sacrifice in line with the spirit of the eid-el-Kabir celebration.

Also, the Chief Imam of the Old Campus Mosque, Professor Sani Musa Ayagi, has called on Muslims to be united and love one another. In his sermon during the eid-prayer at the Old Campus, he noted that without unity, peace and harmonious coexistence, there would be no development.

Professor Giwa who expressed concern at the growing incidences of family disputes, which often result in killings, said lack of adherence to the teaching of the Qur'an and the Sunnah of the holy Prophet were mainly responsible for this negative trend. According to him, there must be mutual respect amongst couples as a way of promoting good family values and proper child upbringing for a better society.

Equally, he called on the youth to be self-reliant and hardworking and to enroll in schools, so as to be productive and contributing to the development of the country. "Islam is a complete way of life. We have to be our brother's keepers."

Presenting the Television Licence to the Vice Chancellor of the University Professor Muhammad Yahuza Bello on Tuesday, 6th August, 2019 in Abuja, the Director General of NBC, Mallam Ishaq Modibbo Kawu, said the licence would afford the institution to start television broadcast for general purposed as well as for training its students.

According to him, the NBC had a long existing partnership with BUK in the area of broadcast journalism.

Already, he said BUK had a community radio station and with this TV licence it is hoped that graduands of the institution will come out a readymade products.

In his remarks, the Vice Chancellor, Professor Muhammad Yahuza Bello, expressed delight to the management of the NBC for the DSB licence, pointing out that the desire to provide the best teaching materials informed the decision for the securing of the operational licence.

He assured that the university would abide by the rules and guidelines of operating the TV station.

Also explaining on the implication of the licence, the pioneer Dean of the Faculty of Communication, and now Dean of the School of Post Graduate Studies, Professor Umaru Pate said the station would give adequate practical training to our students in journalism practice, particularly broadcasting.
